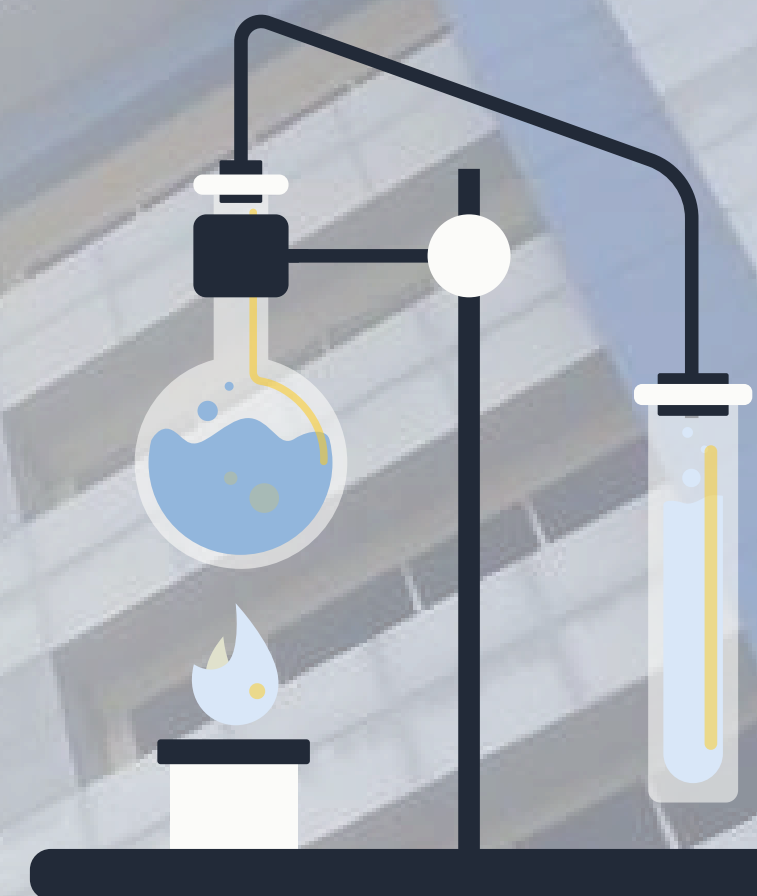




The Clinical Pharmacy Research Group

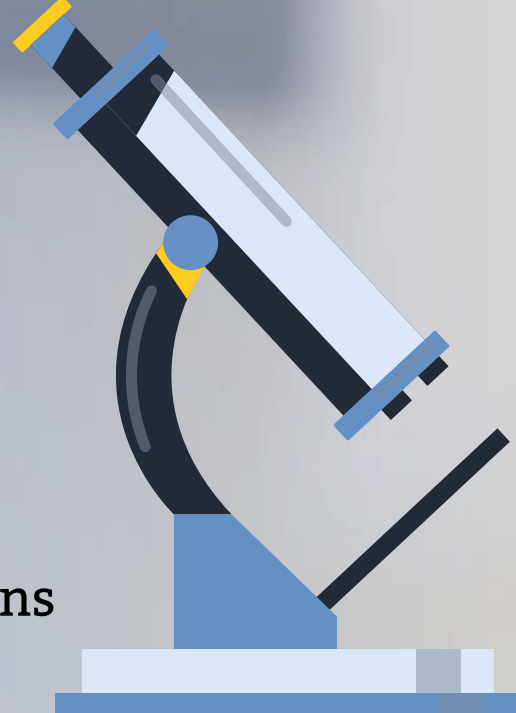
